The column 'Ended studies' shows the total number of students who ended their studies at their own request or their study was terminated due to non-fulfilment of their study obligations.

Full-time study contributes significantly to the qualification growth of young faculty staff. The continuing problem (especially in the combined form of study) is the high number of students who fail to complete their studies within the given period.

4 Students and graduates of FoE UWB

4.1 Interest in study, course and results of the admission procedure

Collaboration with secondary schools in informing applicants

The faculty has long-term relationships with many grammar schools, business academies and other mainly economically oriented secondary schools in the Pilsen and Karlovy Vary regions. Every year, the faculty employees attend a large number of secondary schools and acquaint their students and educational advisers with study fields and activities of FoE. In 2017, the faculty staff also visited selected secondary schools in the Central Bohemian and Ústí nad Labem regions and Prague. The faculty annually sends information materials to selected secondary schools in the Pilsen, Karlovy Vary, Central Bohemian, South Bohemian and Ústí nad Labem regions with the offer of study fields and an invitation to the Open Days in Pilsen and Cheb. To attract potential applicants for study, the faculty organized the traditional HOMO ECONOMICUS Summer School for children and youth in July 2017. In the field of promotion, the faculty also builds its image by posting videos on social media (YouTube and Facebook) and in multimedia presentations at secondary schools. The faculty uses a website to increase awareness of applicants about the admission procedure and fields of study. In 2017, the Faculty informed about the study not only applicants from secondary schools, but also an organized group of foreign students studying Czech language at the Institute for Language Preparation of Charles University in Prague to whom the faculty staff presented the study environment and fields.

The course and results of the admission procedure

In 2017, 1,471 persons applied for study at FoE UWB submitting the total of 1,938 applications (in 2016, it was 1,484 persons submitting 1,845 applications). The overall capacity of study

programmes was given by Chancellor's Decision No. 15R/2017 on the number of recalculated funded students for the 2018 budget given by the overall limit for indicators B1 + N1 + P1 of 692 students for FoE. Based on the above limit, the FoE Dean after a discussion with the Dean's Board decided on the partial values of indicators B1, N1 and P1 for FoE in the same amount as in 2016. In 2017, 52% of applicants were admitted to the full-time bachelor's study and 46% to the combined form of study. 71% of applicants were admitted to the full-time follow-up master's programme and 48% of applicants to the combined form of study. 16 applicants submitted applications for the doctoral study, 14 were admitted, of which 9 for the full-time form. The ratio of admitted and applying persons varied in individual study programmes. As in the previous years, the highest number of applications was submitted for the full-time bachelor's degree programme of Economics and Management in Pilsen and the combined form in Cheb and also for the follow-up combined master's degree programme of Economics and Management. The lower interest of applicants was like in previous years in the bachelor's and follow-up study programmes of Systems Engineering and Informatics and the full-time bachelor's study in the Cheb part of FoE. In the study fields of these programmes, second stages of the admission procedure were announced, with the exception of the bachelor's and follow-up study programmes of Information Management.

The data shown in Table 3 include the final outcome of the admission procedure, including the second stage of the admission procedure, which was announced in the Pilsen part of the faculty for the bachelor's study programmes of Systems Engineering and Informatics (only for the study field of Project Management Systems) and Geography, and in the Cheb part of the faculty for

the full-time bachelor's study programme of Economics and Management. The capacity of study fields at the Cheb faculty was not filled even after the second stage of the admission procedure. The second stage of the admission procedure was announced also for the follow-up master's study programme of Project System Management. The lower number of applicants for the Systems Engineering and Informatics programme reflects the long-term low number of graduates of the Systems Engineering and Informatics bachelor's programme.

Admission procedure for bachelor's study programme

Applicants for the bachelor's study were admitted without entrance examination. If an applicant in stage 1 of the admission procedure met the conditions set by Article 5 of Dean's Notice No. 6DV/2016, the faculty guaranteed their admission to the chosen field of study. The condition for the guarantee of admission to full-time study was not to exceed the limit value of average grades for each term of the penultimate year of study and the first term of the last year of study at secondary school. The set limit of average grades for each of the given terms was 2.00 or 2.50, depending on the applicant's field of study at the secondary school and the field of study at FOE UWB, for which the applicant applied. The condition for guaranteeing admission to the combined study of Business Economics and Management was the successful completion of the Lifelong Learning Programme (in accordance with Section 60 of Act No. 111/1998 Coll., as amended) within the accredited bachelor's study programme of Economics and Management.

Applicants for full-time and combined bachelor's study programmes who did not meet the conditions for guaranteed admission were admitted according to Dean's Notice No. 6DV/2016 in order of the total number of points awarded from the best (the candidate with the highest number of points) until the full capacity of the selected field of study was reached. Applicants were awarded points according to a set formula for average high school grades over the three terms mentioned above. The number of points for a candidate could be increased in a set way if the candidate studied at a secondary school the field of education specified in Dean's Notice No. 6DV/2016 and/or documented voluntary activities specified in the Dean's Notice. The minimum number of points for admission was 20 points. With regard to the number of applicants who met the conditions for guaranteed admission and the free capacity of study

fields for the given place and form of study, the Admissions Board set minimum numbers of points for admission (Table 5).

In stage 2 of the admission procedure for bachelor's study programmes, applicants were in accordance with Dean's Notice No. 3DV/2017 admitted to study within the free capacity of study fields without an entrance examination according to the 'P' value calculated according to the average achievement of the applicant in the last two years of secondary school. Applicants were ranked according to the calculated value of 'P' in order from the best down (i.e. from the lowest value of 'P' to the highest). With regard to the free capacity of the above fields of study for the given place and form of study and with regard to the number of applicants registered in stage 2 of the admission procedure, the Admission Committee decided that all applicants who had sent officially certified copies of school reports from the last two years of secondary school will receive an invitation to enrol. These applicants were admitted if they submitted an officially certified copy of the school-leaving certificate or proof of nostrification of foreign secondary education in the Czech Republic no later than on the day of enrolment.

A necessary condition for admission to study in both stages of the admission procedure was the completion of full secondary education. For applicants who completed secondary school abroad (with the exception of the Slovak Republic), proof of command of the Czech language at least at level B1 of the Common European Framework of Reference for Languages and submission of proof of validation of foreign secondary education in the Czech Republic was a necessary condition for admission.

Admission procedure for follow-up master's study programmes

The entrance exam in stage 1 of the admission procedure had the form of a written test. The general content of the entrance examination for each field of study and the criteria for the entrance examination evaluation were published in Dean's Notice No. 7DV/2016. Applicants did not have to sit the entrance examination if they fulfilled the conditions set by Dean's Notice No. 7DV/2016. Stage 2 of the admission procedure was announced only for the study programme of System Engineering and Informatics, field of Project Management Systems. The form of the

entrance examination, its scope, evaluation and conditions for not having to sit the entrance examination were published in Dean's Notice No. 4DV/2017 and were the same as in stage 1 of the admission procedure for the said field of study. In both stages of the admission procedure, all applicants who met the conditions for not having to sit the entrance examination were admitted to follow-up master's degree programmes. Applicants who sat the entrance examination were admitted in the order of the number of points obtained until the capacity of study programmes and fields was filled. A necessary condition for the admission of applicants who have completed a bachelor's or master's study abroad, was to send an officially certified copy of a certificate of passing a certified examination in the Czech language for foreigners proving knowledge of the Czech language at least at level B1 of the Common European Framework of Reference for Languages, or a certificate of leaving examination in Czech.

Admission procedure for doctoral study programmes:

The entrance examination for the doctoral study programme *P6208 Economics and Management of study field 6208V007 Economics and Management* had a form of an oral discussion of a selected framework topic of the dissertation thesis and general knowledge in the given scientific field. The conditions for the admission procedure were set by Dean's Notice No. 1DV/2017. The Admission Committee evaluated documents submitted by the applicant as part of the application and knowledge demonstrated by the applicant during the entrance examination. On the basis of this evaluation, it submitted a reasonable proposal to the Faculty's Dean for admission or non-admission of the applicant. The course of the entrance examination was recorded by the Commission in a protocol.

The entrance examination for the doctoral study programme *P6208 Economics and Management of study field 6208V086 Business Economy and Management* had a form of an oral discussion of a selected framework topic of the dissertation thesis and general knowledge in the given scientific field. At the same time, the applicant's qualification for completing the ending field of study before the expiry of its accreditation were assessed. The conditions for the admission procedure were set by Dean's Notice No. 2DV/2017. On the basis of this evaluation, the Board submitted a reasonable proposal to the Faculty's Dean for admission or non-admission of the applicant. The course of the entrance examination was recorded by the Commission in a protocol.

Summary statistical information abut the admission procedure in 2017/2018

4.2 Students in accredited study programmes

As of 31.12.2017, 1,431 students were studying at the faculty (not including foreign students studying at FoE within short-term study mobility), of which 1,100 were in bachelor's programmes, 297 in follow-up master's programmes and 34 in doctoral programmes. Year-on-year, the total number of students at the faculty increased by 6 (in bachelor's programmes increased by 39 students, in follow-up master's programmes decreased by 37 and in doctoral programmes increased by 4 students).

The most significant year-on-year changes in the number of students occurred in the full-time form of bachelor's study programmes, where the total number of students increased by 48. On the other hand, in the full-time form of follow-up master's degree programmes, the total number of students decreased by 46 year-on-year. In other study programmes, the year-on-year changes in the number of students were just small.

4.3 So-called Double Degree study programme

In 2017, the Faculty of Economics continued for the fifth year to implement the Double Degree bachelor's study programme of Economics and Management in cooperation with the Hochschule Hof - University of Applied Sciences in Hof, Germany. In June 2017, 2 FoE students completed the Double Degree programme, 3 FoE students in the Double Degree programme at the Hochschule Hof completed their third year of study and started their compulsory 5-month professional work experience in German companies.

4.4 Graduates

In 2017, 345 students graduated from the faculty, which is 31 graduates less than in 2016. There was a year-on-year decrease in the number of graduates in all full-time and combined bachelor's degree programmes (total year-on-year decrease in the number of graduates by 55); on the other hand, there was a year-on-year increase in the number of graduates in follow-up master's degree programmes (total year-on-year increase in the number of graduates by 24). The number of graduates of doctoral study was the same as in 2016.

Employment and employability of graduates and measures to increase it:

To increase the employability of its graduates, the Faculty has been cooperating with ADP Employer Services Česká republika, a.s., Moore Stephens, Deloitte, Plzeňský Prazdroj, a.s. and developing cooperation with other potential employers in the Pilsen and Karlovy Vary regions (e.g. Diebold Nixdorf, ČSOB, AIMTEC, PMDP, a.s., Škoda Transportation, a.s.). FoE also publishes offers of external organizations for student internships and sent information about offered job opportunities on its pages on the social network Facebook. Part of the study plans of all

economic fields of study in the bachelor's and follow-up master's degree programmes at FoE is a compulsory course of Professional Work Experience, or Pre-diploma Work Experience where students gain practical experience and materials for the processing of their qualification work and have the opportunity to establish contact with potential employers.

Cooperation with future employers of the graduates:

FoE has been cooperating with potential employers (including above-listed organizations), e.g. within the sustainability of the UNIPRANET project. The cooperation is realized in the form of professional work experience in both the private and public sectors, the outcome is usually a topical paper. Potential employers are also invited to lectures, conferences and workshops organized by the faculty. FoE also develops cooperation with potential employers through its Business Centre. In cooperation with Employer Services Česká republika, a.s., a course was organized in the Basics of German Payroll Accounting, whose successful graduates were offered the opportunity to work in this company.

Cooperation and maintaining contact with the graduates:

The faculty maintains contact with its graduates through departments and social media (Facebook, LinkedIn and YouTube), where it informs its graduates about upcoming events and news from the faculty life. Social media have also provided an opportunity to create unofficial graduate clubs. In 2017, the departments cooperated with graduates in supervising bachelor's theses (for example in the field of Marketing). Cooperation with graduates also takes place in the form of lectures and workshops in teaching of selected topics, the cooperation is developed in particular with the consulting and advisory companies Moore Stephens and Deloitte.

4.5 Unsuccessful students and measures for the reduction of study failure rate

In 2017, 346 students unsuccessfully ended their study at the faculty, which is the same number as in 2016 (the number of unsuccessful students increased by 9 in bachelor's programmes, decreased by 5 in the follow-up master's programmes and decreased by 4 in the doctoral study programmes).

The faculty has been struggling for a long time with the study failure rate, especially with students in the first year of the bachelor's study. Students who ended their studies during the first year of the bachelor's study in 2017, or whose studies were terminated after the first year, accounted for 70% of all unsuccessful students in the bachelor's study. At higher levels of study, the share of unsuccessful students from Year 1 in the total number of unsuccessful students in the given stage of study was more than 50%.

Measures to reduce study failure rate

The faculty has long struggled with the failure rate of Year 1 students in bachelor's study programmes, of which some students do not attend classes and do not show interest in studying each year. The Faculty does not have the possibility to identify such applicants during the admission procedure and prevent their admission. In Year 1 of the bachelor's study, FoE focuses on helping the adaptation of students to university studies and reducing differences in initial knowledge in selected subjects. In 2017, Year 1 students got acquainted with the specifics of university studies, e.g. in the compulsory subjects of Study and Work with Resources, Psychology for Economic Practice and Introduction to Geography. Graduates of humanitiesoriented secondary schools were offered at enrolment the optional course of Seminar in the Basics of Mathematics, the aim of which was to balance out knowledge of mathematics and to increase students' success in studying mathematics. Students from non-economic secondary schools were offered the optional course of Basics of Accounting, which prepared students for the study of the compulsory subject of Accounting. FoE continuously cooperates with the management of the Institute of Language Training of UWB and with the staff of the FAS Department of Mathematics in solving the failure rate in the study of English and mathematics. In 2017, FoE implemented activities within IP-Education 2017: Measures to reduce study failure rate, which included analytical work, preparation of questionnaire surveys, elaboration of a proposal for more effective work with Year 1 students, preparation of study aids for selected subjects, organization of extended group consultations and other activities. The experience from these activities is used in the selection of measures to reduce study failure rate within the key activity KA7: Adaptation of the study environment, in which FoE participated within the university project of ESF.

FoE students from all years and forms of study can use study support in the form of e-learning courses in a number of subjects. All compulsory and almost all optional-compulsory FoE subjects actively use the Courseware system. Based on the great demand of students, FoE annually organizes short-term lifelong learning courses aimed at supplementing knowledge from selected subjects and courses to prepare for the state examination in Economics at the bachelor's and follow-up stage of study. The FoE management and heads of departments continuously monitor and evaluate the results of course performance; in addition to data from IS/STAG on course performance, they also use the results of electronic assessment of teaching quality and personal consultations with students to analyse the study success. To increase students' awareness of study issues, enrolment in study is used at the beginning of the academic year, and during the academic year, it is mass e-mail, faculty website STUDIUM (http://www.fek.zcu.cz/studium.php), personal consultations and meetings of heads of departments with students.

4.6 Conditions for checking the study

The course of study is checked in accordance with the UWB Study and Examination Regulations. The basic forms of control are credit, examination and final state examination. Effective from September 2013, the FoE AS approved the reduction of the required minimum number of credits for the first semester of study to 10 credits (re-approved by AS FoE in 2017 and provided in Dean's Decision No. 6DR/2017). Further, the UWB Study and Examination Regulations require students to obtain at least 40 credits for the first year of study and 80 credits for each of 4 consecutive semesters. Dean's Decision No. 3DR/2017 sets the mandatory attendance of students in practice lessons and seminars of FoE subjects included in the first semester of the bachelor's study programmes to 75%.

4.7 Innovation of study

In 2017, the academic staff of FoE UWB used teaching materials and study support, including elearning courses of LMS Unifor, which were created in previous years as part of the Complex Innovation of the Bachelor's Study Programme of Economics and Management (INEM) project. At the same time, several new study aids (textbooks, exercise books and collections of examples) were created within *IP-Education 2017: Measures to reduce academic failure rate*. Employees of the Department of Marketing, Trade and Services acquainted students with modern technologies (e.g. eye camera), which students use at the Department to work on their theses in marketing and market research. In 2017, an automatic task generator for generating examples from selected subjects was developed at the KEM Department. All FoE departments include in lessons lectures by leading experts from companies, banks, public administration institutions and other organizations.

4.8 Re-accreditation

In 2017, the faculty prepared annotations of proposals for accreditation plans for the planned bachelor's study programmes of Marketing Management and Project Management and for the planned follow-up master's study programmes of Economic and Regional Geography, Project and Process Management and Real Estate Management and Development. The annotations were discussed and approved by the relevant bodies and boards of FoE and UWB. Subsequently, during 2017, work began on the preparation of accreditation plans with the aim of submitting applications for accreditation for the above-mentioned study programmes in the first half of 2018. The Faculty also sent an Audit Report on the bachelor's study field of Business Activities Management to the National Accreditation Office through the UWB Chancellor's Office in spring 2017; the report was accepted without comments.

4.9 Awarded students

Special Scholarship of UWB Chancellor in 2017 was awarded to **Ing. Olga Šlechtová Sojková**, a Year 1 student of a doctoral study programme at FoE, for active involvement in the activities of FoE in the field of research and development and the third role of the university.

Special Scholarship of UWB Chancellor for Sports Achievements in 2017 was awarded to **Lukáš Provod,** a Year 2 student of a bachelor's study programme, for excellent representation of the UWB in football.

Scholarship of the President of the Pilsen Region in 2017 was awarded to **Bc. Libor Kůs,** a graduate of the bachelor's study programme of Geography, for active participation in joint cross-border research of KGE and the Geo Institute of the University of Bayreuth and joint cross-border research with Bavarian students.

Scholarship of the Mayor of Pilsen in 2017 was awarded to:

5 Educational activity at FoE UWB

5.1 Accredited study programmes and fields

Accredited study programmes of FoE UWB are implemented in a credit system. The number of credits reflects the level of the student's workload in the subject, it is derived from the number of hours of contact learning, while also taking into account the difficulty of the student's individual preparation. For any accredited study programme and field of study, the faculty has no specific health requirements for applicants and students.

Assessment of the quality of work experience in the bachelor's study is the responsibility of the guarantor of the subject of Professional Work Experience, in the follow-up master's study it is the responsibility of the thesis supervisor.

Students' work experience is based on the assignment of the thesis and is focused on learning about the internal environment of the company and the environment in which the company operates. Assessment of the quality of work experience in the bachelor's study is the responsibility of the guarantor of the subject of Professional Work Experience, in the follow-up master's study it is the responsibility of the thesis supervisor.

The assessment of the quality of practice in the bachelor's study is in the competence of the guarantor of the subject of Professional Work Experience, in the follow-up study in the competence of the thesis supervisor. KMO cooperates with many companies and institutions in arranging work experience and producing bachelor's and diploma thesis.

d) CECEV activity

CECEV organizes lifelong learning in study programmes of fields and subjects taught at the faculty. In all forms of lifelong learning, the participants or their employees have to pay for the study. Lifelong learning is provided in both the combined and full-time forms. The main part of CECEV activities is the organization and provision of study programmes, complete blocks of subjects and services of the combined form of study for students. In addition, CECEV organizes for the Institute of Lifelong Learning the operation of the University of the Third Age (U3V) in Cheb and Aš, training courses for students and the general public (languages, mathematics and others), continuing education in companies and participates in educational projects. In its activities, it cooperates with partners in the region, such as the City of Cheb, the City of Aš, the Regional Library of the Karlovy Vary Region, the Regional Chamber of Commerce of the Karlovy Vary Region and educational institutions. For its activities, it mainly uses educational facilities in Cheb and Pilsen.

For the combined form of regular study at FoE UWB, the Lifelong Learning Centre carries out the organization of tutorials and the related administration.

e) University of the Third Age in Cheb and Aš

The University of the Third Age (U3V) in Cheb and Aš is organized by the Centre of Lifelong Learning of FoE UWB for the University of the Third Age of UWB. The implementation is financially supported by the City of Cheb and the City of Aš, as well as by the Ministry of Education, Youth and Sports. The University of the Third Age is open to the general public. Each of the courses offered is taught according to relevant regulations in one semester in the range of 16 lessons (8 two-hour sessions) and is completed with a control work (e.g. test, essay, paper). Individual courses of the University of the Third Age are included in the study programmes. After completing the prescribed number of six courses, four of which in one study

programme, the participant of the University of the Third Age can 'graduate'. It has become a tradition that the graduation ceremony for the participants of the University of the Third Age takes place together with the graduation ceremonies of the students of the Faculty of Economics.

5.4 Development of the Faculty of Economics and the Lifelong Learning Centre in Cheb

In 2017, the city of Cheb provided a contribution to the running and development of the University of the Third Age (U3V) and the Cheb part of the faculty in the amount of CZK 500,000. The contribution was used mainly for scholarships of selected students of Year 1, the payment of admission and transport during field trips organized within the U3V learning, for the partial payment of fees of U3V lecturers (lecturers without full-time employment at UWB, payment of DPP, DPČ), for stationary and copier material for the Lifelong Learning Centre. Furthermore, the contribution was used to purchase an electronic whiteboard, to upgrade hard disks and operational memories in one computer room and lecturer notebooks, and to purchase one data projector. It was also used to pay for the upgrade of Unifor e-learning system, which is used for all types of study.

5.5 Applying new forms of teaching

In 2017, the faculty participated in the key activity *KA2: Improving educational activities and modern teaching trends*, which is part of the ESF university project. This key activity involves all FoE departments, whose staff participate in trainings, seminars and workshops focused on subject innovation, new teaching methods, creation of new materials and strengthening of the practical component of teaching. New teaching methods will be introduced into the subjects and evaluated gradually during the project.

When applying new forms of teaching at FoE, the starting point is the technical support of the educational process at UWB. The basic information support is arranged in the form of UWB electronic portal, including the Courseware information system, for subjects taught. The faculty also has LMS Unifor and LMS Moodle available for creating online courses with asynchronous tutor support. FoE students from all grades and forms of study can use study support in the form of e-learning courses in LMS Unifor or LMS Moodle in a number of subjects. Credit tests in selected subjects are transferred to LMS Moodle. All compulsory and almost all optional-compulsory FoE subjects actively use the Courseware system. Electronic means are also used, e.g. for submitting seminar and other papers, checking the similarity of papers, communicating with teachers at selected times via Skype, or for video conferencing.

7 External relations of FoE UWB

7.1 International collaboration

In the area of international cooperation, the most important project is **Erasmus+**, which is coordinated by the Foreign Section of UWB in Pilsen. As of 31 December 2017, the Faculty conlcuded a total of 57 agreements (same number as in 2016) with 52 partner universities (same number as in 2016) in 16 European countries and a project with associated Turkey. Compared to last year, there were two fewer partner universities - Copenhagen Business Academy (Denmark) and INUAF Loulé (Portugal). And two new contracts were added, with UNIVPM Ancona (Italy) and Fachhochschule der Wirtschaft, Graz (Austria). The majority of contracts were signed with universities in Germany (14), France (8), Poland (6), Turkey and Spain (4). In 2017, the faculty offered a total of 879 months of internships for up to 149 students and 71 weeks of internships for up to 72 teachers within teacher mobility.

In addition to student mobility, the faculty enables its staff to travel to partner workplaces. In 2017, a total of four employees went to Erasmus+ Teacher's Mobility in four countries (Hungary, Spain, Slovenia, Finland), where they worked at one of the partner workplaces every week. The long-term goal is to maintain and develop contacts with all workplaces with the same intensity, if possible. Six employees visited partner workplaces in four countries (Slovakia, Italy, United Kingdom and Germany) within Erasmus Staff Training.

Teaching of foreign students from partner schools at FoE in Pilsen is in English. In 2017, there were 30 subjects offered to foreign students, the number was the same as in 2016.

Since 1996, more than 20 years after the organization of the first semester course, there has been collaboration with the College of Business Administration at Marquette University Milwaukee (WI, USA). Students from this university create projects with FoE students and meet at workshops in the Czech Republic, the USA and on the internet. Each year, these international projects end in a joint presentation at the American university. The project also includes lectures by teachers from partner faculties. In 2017, 10 students from our faculty and 11 students from the Marquette University participated in a joint project. This project was traditionally realized in cooperation with the Department of Foreign Relations at UWB and was actively attended by two faculty staff.

The faculty also maintains bilateral relations with non-European partner universities. These bilateral contracts relate to student and teacher mobility and R&D collaboration. In 2017, it offered cooperation with Escuela Bancaria y Comercial (EBC) in Mexico City (Mexico); Sogang University in Seoul (South Korea); Chienkuo Technology University in Changua City (Taiwan); Beijing Institute of Technology (BIT) in Beijing (China), Ural State Economic University and Ural Federal University of BN Yeltsin in Ekaterinburg (Russia), Manhattan Institute of Management (MIM) in New York and Shanghai Finance University (SFU) in Shanghai (China).

A joint bachelor's 'double degree' programme in the study programme of Economics and Management has been successfully implemented for the fifth year in cooperation with Hochschule Hof (see also chapter 4.3).

For the promotion, motivation and dissemination of information about the possibilities of trips abroad, on 24.10., 26.10. and 1.11.2017, contributions to lectures to Year 1 of the bachelor's study in Pilsen and Cheb were organized and mobility programmes presented. The purpose of such visits directly in classes is the fact that Year 1 students are acquainted at the beginning of their studies with all the possibilities of study programmes abroad, to which they can gradually apply during the following semesters of their studies. A total of 355 students were addressed in this way. The traditional 'Erasmus Day', which the faculty organized in recent years, was cancelled after being evaluated as not very effective. The following year, it will be replaced by 'Erasmus Night' event, which will also serve to promote mobility; its implementation is scheduled for next spring. All detailed information on student mobility can be found on the new website <u>mobility.fek.zcu.cz</u>, which was created and launched in 2014 in order to clearly gather information on all types of international mobility that are provided at the faculty and more necessary information is gradually added to it.

7.2 Foreign mobility of students

The following tables show overviews of FoE student visits to foreign partner universities as well as arrivals of foreign students to FoE in the calendar year of 2017 (not in the academic year from which the indicators for K-coefficient are calculated). Student-days are calculated only with mobilities over 30 days.

Compared to 2016 (54 students), the number of students going out decreased by 26%. The year-on-year decrease of cumulative student-days compared to 2016 (5,592) is 29%. The most frequent destinations to which our students went were Germany (15 students), Greece (4 students), Spain, Finland and the Netherlands (3 students each). Compared to 2016, the number of foreign internships increased (in 2016 only 3 internships).

Compared to 2016 (55 students), there was an increase by 5%. Compared to 2016, the number of student-days increased by 12% (students had longer stays on average than their predecessors). The most frequent destinations from which students came to us were France (13 students), Spain (8 students), the Netherlands and Russia (7 students), Mexico (6 students) and Germany (5 students).

Thanks to the cooperation with the Institute of Czech-Brazilian Academic Cooperation (INCBAC), our faculty welcomed also in 2017 interns from among Brazilian students within the UNIGOU programme. Two Brazilian students worked at the KPM and KGE departments and, under the supervision of local academics worked on their projects, which they then presented at a joint meeting of all programme participants in Prague.

8 Partnerships and collaboration of FoE UWB

8.1 Cooperation of expert departments with regions and professional organizations

KFU

KFU is a member and cooperates with the Czech Association for Financial Management (CAFIN) and the Czech Treasury Association (CAT) within professional education of academic staff and students. The Department cooperates in the long term with the basic organization of the Association of Accountants in Pilsen on the development of education in the accounting profession in the region.

KFU has been developing cooperation with ICAEW - Institute of Chartered Accountants in England and Wales. Based on meeting professional and ethical standards of education, the department has been awarded the 'Partner in Learning' certificate by this leading world professional organization, which entitles graduates of the Department of Finance and Accounting subjects to the recognition of ICAEW professional exams. Another form of cooperation with this organization is the organization of interactive workshops and business games for students. In 2017, students had the opportunity to watch the presentation of *False Assurance*, a film drama sparking discussions about how accountants, auditors and company directors should act in difficult situations. This event focused on the development of ethical judgements, the support of students' critical thinking and the discussion of the problems of practice of financial professions.

The department maintains a long-term cooperation with the company Moore Stephens. The aim of the collaboration of KFU and Moore Stephens is to connect students' theoretical knowledge with the challenges and requirements of the labour market and business reality. The cooperation takes place firstly on the level of invited lectures and seminars led by company specialists within the courses guaranteed by the KFU, and secondly on the level of cooperation in the processing of students' diploma and bachelor theses. As part of the cooperation, the company also offers the possibility of professional internships and job opportunities for students and graduates. In 2017, experts from Moore Stephens gave lectures for students and shared their experience from the field of tax and audit.

A similar type of cooperation was established by the Department with Deloitte and KPMG, both in terms of professional lectures and the possibility of attending work experience for students. In the autumn of 2017, KPMG representatives discussed audit and financial statement handling issues with students. Experts from the Pilsen branch of Deloitte presented to students a view of the current entrepreneurial risks in the Czech Republic and the approaches of financial administration in connection with the use of the hedging order tool.

In 2017 continued close cooperation of KMO with companies and entities in the region:

The Department organized an international conference 'Opportunities and Threats to the Current Business Economy in Cross-Border Comparison 2017'.

A Department representative is a member of the working group Economy in the project 'Upper Palatinate and the Pilsen Region - Together in the Centre of Europe'.

Two significant contract researches were carried out at the Department for the Government of Upper Palatinate and the company Aim Agentur s.r.o.

Representatives actively participated in important events in the region, such as the General Assembly of the Nürnberg Metropolitan Region, conferences within the project 'Upper Palatinate and the Pilsen Region - Together in the Centre of Europe', the 2nd Czech-Bavarian University Forum and others.

In the field of internet marketing, collaboration continued with ANT studio s.r.o. Plzeň and several invited lectures were organized for FoE students: Ing. Viktor Janouch, Ph.D, a leading expert in internet marketing; Jindřich Wiendl, marketing and advertising agency Jiní než jiní.cz in Pilsen.

Within the projects prepared by students in the subject of Marketing Project (PROMO), cooperation was realized with the following entities: Hotel Ibis (Plzeň), Tralalala, MOE´S, ZjistěteCoJíte.cz, Česká Spořitelna, Trhy Aleš, MURR CZ, Dativery, Czech-American TV, QAP.cz, NěmeckýEshop.cz.

Professional and project cooperation was realized with the Regional Chamber of Commerce of the Karlovy Vary Region, RHK of the Pilsen Region, the City of Pilsen, the City of Cheb, regional authorities of the Karlovy Vary and the Pilsen regions, the Karlovy Vary Business Development Agency, Destination Management West, SANEK Ponte, o.s., Techmania Science Centre o.p.s., CzechTourism, Františkovy Lázně spa, Plzeň - TURISMUS, p.o., Pilsner Urquell, NIDV, Junior Chamber International (JCI), Industrie- und Handelskammer Regensburg für Oberpfalz/Kelheim or EUROTOURS International and the Bone Marrow Transplant Foundation.

KMO staff are members of a working group for research and education at the Tourism Institute of the Czech Tourism agency.

At the same time, in the second half of 2017, KMO carried out an evaluation for CzechTourismus of the Marketing Information System of Tourism, which should lead to an improvement in the user-friendliness of this system.

The cooperation with Dolní Poohří Destination Agency and Litoměřice Tourism Centre also continued - membership in the preparatory committee and hosting of the Stop and Stay 2017 conference.

Expert field trips were realized within the subject of Geography of Tourism with destinations in Klatovy, Cheb, Františkovy Lázně or Pošumaví. As part of the Studykom project, a 4-day field trip was organized to the Czech-Bavarian border area and attended also by students of the University of South Bohemia and TH Deggendorf.

Selected students of the subject of Marketing Management of a Company led by Ing. Dita Hommerová, Ph.D., MBA participated in the interdisciplinary project Design+ in cooperation with students of FST, FZS, FDULS - interdisciplinary teams solved specific tasks from business practice (manufacturing companies), the activity ended with a competition workshop.

An activity of the local section of the Czech Marketing Society was supported, for example by organizing an expert lecture on the possibilities of using eye tracking.

In May 2017, students and professors from the Hochschule Harz (Wernigerode, Germany) visited for the eleventh time as part of their field trip, which was co-organized by KMO.

In June 2017, KMO organized a study stay of students of OTH Regensburg led prof. dr. Thomas Groll, who solved a case study in the field of service design at UWB.

In December 2017, KMO students, in cooperation with the Bone Marrow Transplant Foundation, organized a Christmas meeting #NADŘEŇ at the Družba university café.

KPM

Also in 2017, the cooperation of the department continued primarily with the corporate sector, but also with other institutions. The cooperation took place mainly in the form of involvement of experts in teaching, both through selected professional lectures and tutoring practical lessons and seminars, especially in specialized subjects. Experts from practice also acted as supervisors or consultants for bachelor's or master's theses. In cooperation with the Society for Project Management (SPM), we managed to obtain the 'National Certification of Students' certification. The certificate can be obtained by students within the subject of Project Management, which is guaranteed by our Department. Members of the Department also played an important role in the activities of the Business Centre, where a number of events took place at which students had the opportunity to get acquainted with the local business environment. The Department participates in international collaboration. As part of the UNIGOU Academic Internship programme, Wagner Firmino Junior, a Brazilian intern, who was involved in the Department's research activities, stayed at the Department in January and February. In March, dr. Witold Nowiński from WSB University in Poznań, with which the Department has been cooperating for several years, was a guest at the Department. During his stay, dr. Nowiński gave lectures in the subject of Business Activities in English.

KEM

KEM has a long-term collaboration with the Czech Statistical Office, mainly with the regional office for the Pilsen Region.

The Department cooperates with Diebold-Nixdorf, whose important delivery centre is located in Pilsen. This cooperation is focused especially on students of Information Management.

KGE

The Department cooperates with the regional authority of the Pilsen region, in particular with the Department of Regional Development and the Department of EU Funds and Programmes, with the Department of Concept and Development of the City of Pilsen, the Regional Administration of the Czech Statistical Office in Pilsen and the Administration of Brdy Protected Area (CHKO). Other partners include CHMI - Pilsen branch, Ametyst - Environmental Education Centre and the Czech Geographical Society.

The Department also cooperates with six Central European universities in the so-called Scientific Hexagon of the universities in Bayreuth-Bratislava-Graz-Maribor-Pécs-Pilsen and newly with the Ostbayern-Böhmen Academy.

In 2017, KGE hosted Brazilian intern Marcela Campos within the UNIGOU INCBAC programme.

During the autumn, she gave several lectures at secondary schools as part of the so-called Days of Geography (organized by the Czech Geographical Society), which was followed by a joint meeting of department staff and Geography graduates.

8.3 Project Activities Centre

The mission of the Project Activities Centre (SPA) is to increase project activity of all FoE sections, including research and development projects. The Centre focuses on the following activities:

- identification of the potential and know-how of FoE sections in the project area;
- monitoring and searching for suitable grants;
- helping with searching for project partners;
- developing contacts with the public and business sectors, educational and advisory agencies, regional development agencies, BIC, chambers of commerce and other entities;
- cooperating with relevant sections of the UWB's Chancellor's Office;
- informing FoE staff about opportunities for participation in project activities, training, seminars and other events aimed at participating in projects;
- assistance and consultations in the preparation of projects formally (subject matter will be provided by sections submitting project proposals).

This mission reflects the professional focus and know-how of FoE and is in line with the long-term development plans of FoE and UWB.

The Centre includes a Project Office whose main aim is to provide methodological support to the proposers or solvers of research and development projects, assistance in their administration and training focused on particular areas of research projects. The Project Office participates in the above activities in accordance with the Centre's mission.

In 2017, the Centre participated in terms of methodological and administrative support in the implementation of GAČR and TAČR projects, incl. preparation of projects for the mentioned grant schemes. The Centre also cooperated on the implementation of university-wide OP EC projects (cooperation with the UWB Project Centre). Furthermore, its employees participated in the administration of a competition of projects of the UWB grant system and the Internal Competition. Since 2017, the staff of the Centre has also supported the implementation of the STUDYKOM project. The Centre ensures sustainability of ES OP projects UNIPRANET and SYPROM.

A workshop for DSP students focusing on Economics and Management took place at SPA in 2017. Specifically, it was a series of working meetings, the aim of which was to acquaint students with the basic issues of their activities in the field of study and R&D. Students also had space to present their research focus and partial outputs.

8.4 International Activities Centre

In 2017, the International Mobility Section of SMA provided all faculty activities regarding international relations. Its main activities include registration and administration of bilateral Erasmus+ agreements, cooperation with foreign partner universities, searching for other possibilities of international cooperation, consultancy for students on the possibilities of foreign studies, organization of workshops on foreign mobility, organization of selection procedures for student international mobility and mobility of academic staff and consultancy for foreign

students. It also focuses on promoting mobility in the form of campaigns (e.g. admissions to student lectures, promotional videos from trips posted on YouTube and Facebook) and seeks closer cooperation with student organizations (e.g. ESN). It manages and is fully responsible for the website <u>mobility.fek.zcu.cz</u>.

8.5 Centre for Regional Development Research

The Centre for Regional Development Research (SVRR) has been working at the Faculty of Economics of the University of West Bohemia in Pilsen since 1991. It carries out applied research of local and regional development and consultancy and expert activities for municipalities, cities and regions. In 2017, the projects 'Image of the City of Pilsen through the Eyes of University Students', 'Research on Current Problems of Municipalities and Cities in the Czech Republic' and 'Strategic Planning in Moldova - Evaluation of the Czech Development Agency Project' were solved at the workplace. At the same time, the following projects of the Czech Technology Agency were prepared: 'The Future of Countryside in the Czech Republic: Challenges, Visions, Development Scenarios and Adaptation Strategies' and 'Revitalization of Urban Centres and Other Public Spaces in the Czech Republic: Problems, Foreign Inspiration, Possible Solutions' which will be implemented in the next three years.

8.6 Business Centre

FoE has a Business Centre, which organizes 'Business Date' workshops for students of all UWB faculties interested in entrepreneurship, start-ups and other related topics. In 2017, the activities of the Business Centre were mainly in the spirit of cooperation with important partners in the field of business support in the Pilsen Region (e.g. DEPO2015, JCI West Bohemia, BIC, etc.). 'Business Dates' focused on the so-called Pilsen Business Boiler. A total of 4 inspiring and networking meetings titled the Pilsen Business Boiler took place on the following topics: online marketing, brand, coaching and the profession of the future. A total of 201 people from among students, entrepreneurs or representatives of both the private and public sectors took part in these events. In addition to these activities, the Business Centre provided information support throughout the year in the area of starting a business and connected representatives of various sectors in order to support business activity. At the same time, the activities of the Business Centre were presented at the 2017 Start Up Show (29.3.2017, organized by CzechInvest) and during the Freezing Week at the partner university HAMK, University of Applied Sciences, Finland (6.-10.2.2017).

9 Social, hobby and sports activities of FoE UWB

At the Cheb part of FoE UWB, sports club USK Akademik o.s. provides leisure, recreational and sports activities for students. USK Akademik o.s. also organizes sports tournaments and social events for students and teachers. These club activities help develop social and friendly relationships between students and teachers.

Prestigious activities at the Cheb part of the faculty include the 'Bucket of Academic Blood', which is organized at FoE twice a year. It is a voluntary blood donation by students, graduates

and friends of FoE UWB. In 2017, the 48th and 49th season of this event took place. Cooperation continued with students of the Secondary Nursing School and the College of Nursing in Cheb and cooperation was established with the Regional Association of the Czech Red Cross in Cheb.

In 2017, the faculty was actively involved in the promotion of the so-called "Prvákoviny" (event organized by the student organization AIESEC), and for this occasion, several students starting Year 1 participated in the event. There is also a close cooperation with ESN on the organization of incoming mobility.

Students and academicians of the faculty participated in a university-wide relay Run with the Chancellor, which was won by a duo of our students, Lukáš and Tomáš Kadlec. The faculty finished second in the second season of the year-round sports tournament for the 'UWB Chancellor Cup'.

10 Other significant faculty activities and important events

10.1 External lectures

During 2017, several personalities who lectured at the faculty visited the Faculty of Economics. They were:

Andrej Babiš (Minister of Finance of the Czech Republic) lectured on 28.3.2017 on 'Tax and Fiscal Policy'.

Vladimír Dlouhý (President of the Czech Chamber of Commerce) lectured on 29.3.2017 on 'Macroeconomic Development of the Czech Republic in Comparison with the EU'

Tomáš Sedláček (ČSOB's macroeconomic strategist) lectured on 10.4.2017 on 'Macroeconomic Situation in the World, Brexit and Global Trends'.

Petra Valentová (owner of Dlouhovláska.cz and a FoE graduate) lectured on 15.5.2017 on her successful business development in the field of hairdressing.

George Deriso (professor at the University of Colorado, Boulder; expert in business and startups) held a practice-oriented workshop titled 'How to Start and Develop Your Own Business' on 19.10.2017. A day later, he led a discussion with academics from FoE and other UWB sections.

John Honer (founder of Czech-American TV) presented this media project to students on 30.10.2017.

Nora Dolanská (founder of the Central Bohemian Tourist Headquarters) gave a lecture on 30.10.2017 on 'Tourism Marketing on the Example of the Central Bohemian Region'.

Oldřich Dědek (member of the Bank Board of the Czech National Bank and former national coordinator for the introduction of Euro) lectured on 8.12.2017 on 'The future of Euro and the Eurozone'.

On 9.11.2017, Mark Harrison (founder and CEO of ACCEE - The Association of Credit for Central and Eastern Europe) presented current trends in the cash flow management, risk management and the development of modern technologies in financial professions.

Marcelína Horáková (an expert on budgets within public administration) lectured on 30.11.2017 on the practical aspects of preparing and compiling a budget of an organizational unit of the state.

Petr Janeček lectured on 30.11.2017 on the Office for Foreign Relations and Information (UZSI) and the possibilities of employment of FoE UWB graduates at UZSI.

10.2 Significant activities and events

The Department of Finance and Accounting (KFU) has continued its collaboration with the ICAEW (Institute of Chartered Accountants in England and Wales). In 2017, it received again the title of 'Partner in Learning' of this organization. In 2017, cooperation was initiated with IISES (The International Institute of Social and Economic Sciences) in the field of organizing professional conferences.

The Department of Geography (KGE), in cooperation with the Faculty, organized a philosophical bilingual exhibition 'Africa of Dreams and Realities after 70 Years', which was compiled to mark the occasion of the 70th anniversary of the Hanzelka-Zikmund journey to Africa and which charts the transformation of the African continent in the last 70 years. This exhibition was supported by the Chancellor's Fund, the Pilsen Region and the City of Pilsen. On 19.4.2017, a workshop and opening took place at the City Hall, and the exhibition was then presented at the PF and FoE premises. Subsequently, it was sent to selected embassies in Africa. In the autumn, it was presented at the Czech Embassy in Addis Ababa in Ethiopia as part of the celebrations of the anniversary of the founding of Czechoslovakia and then as a cultural part of a film festival at the local British Council.

In 2017, the Department of Marketing, Trade and Services followed on the previous period and further strengthened the cooperation with the non-profit organization Czech-American TV. This television is broadcast on cable in the Chicago metropolitan area and can also be watched on the internet (www.catvusa.com). The organization aims to promote the Czech Republic and Czech culture, in particular in the English-speaking world. Among other things, it cooperates with the Czech Tourism agency, FAS UWB, CTU and other workplaces.

The 19th season of the Ball for students and graduates of the Faculty of Economics took place on 18.3.2017 in Cheb. Anna K. and her band performed as the main guest. A short interview was also conducted with the artist, which was then posted on the faculty's YouTube channel.

The Faculty of Economics actively participated in the **2017 Science and Technology Days project on 8.-9.9.2017**. The stand, which was jointly prepared by the departments of KGE, KMO and KEM, was called 'We Plan the City's Development' and presented economic fields and regional development in the form of fun interactive games.

On 18.-19.5.2017, the KMO Department organized the conference **Opportunities and Threats** for the Current Business Economy in Cross-Border Comparison 2017 at the premises of the

UWB Bory campus. This conference was attended by over 50 academic staff, DSP students and practice representatives from the Czech Republic and Germany. The main topics of the lectures and contributions were focused on business in services, destination marketing and management, innovation and quality in services, but also business economy, financial and tax aspects of business and more. The topic of Industry 4.0 and its impacts on the current functioning of companies was also discussed during the debate.

On 15.11.2017, doc. Michaela Krechovská was selected as a candidate for Dean in the secret election of the Faculty Senate and shall take up her office on 1.3.2018 after being appointed by the UWB Chancellor.
